It has since greatly expanded to include a number of additional services and operations. In early [YE 43](#) at the [Galactic Swap Meet of YE 43](#) the corporation represented a number of parties interested in selling their salvage by proxy.

Operations

Below are the areas of business the Fuji Corporation operates in.

Import/Export

The import/export department is responsible for dealing with customs agencies of Yamatai and foreign nations.

Business to Business

The Business to Business (B2B) Department is responsible for purchasing and selling all non-contracted products needed.

E-Commerce

Fuji Corporation operates a small e-commerce platform it uses both to sell its products, operate certain brokerage services, and as a platform for others to operate on.

Fuji Corporation operates a number of stores in Inuyama-shi [Tatiana](#) under the brand name: Ryu Garden Supermarket. In [YE 43](#), they expanded into restaurants at [Port Jiyuu](#) with the opening of 3 Chef Huang Lianjia Restaurants.

Legal

The legal department is responsible for keeping SKB and all Ryu-Mizumitsu holdings legal. Their teams of lawyers can be found throughout Yamatai and Nepleslia addressing any legal challenges that come their way.

Subsidiaries

Fuji Corporation is also manages corporations the [Sakura Trust and Bank](#) owns 51% or more in.

United Kikyo Food Corporation

Established in [YE 30](#), United Kikyo Food Corporation (UKFC) is a small company that manages a number of small agricultural developments such as fisheries and rice farms. As of [YE 43](#), UKFC is looking to begin processing some of their products themselves for use with [Ryu Keiretsu](#) managed restaurants and markets as private labels.

Ryu and Liu Apparel

Ryu and Liu (柳刘) is a play on words, using the fact that the character for ryu is pronounced as liu in Lianjia Speech. The company specializes in producing clothing for the common working man that is both practical and stylish. A number of dissatisfied Lianjia from rival companies pretending to be customers

Established in [YE 43](#), Zhuhai Medical Industries is a biotechnology corporation of former employees of a Nepleslian counterpart. Headed by Qin Jun, the company is looking to re-establish itself under a new brand. Zhuhai Medical Industries will specialize in cybernetics, nanomachines, and pharmaceuticals. With the acquisition of [Advancer Enterprises](#), Zhuhai Medical Industries has been regulated into a medical research think tank.
